

STATO DI ATTUAZIONE DEL PROGRAMMA DI ACQUISTO DI AZIONI PROPRIE A SERVIZIO DEI PIANI DI INCENTIVAZIONE DEL GRUPPO

Milano, 19 febbraio 2026 – Nell’ambito del programma di acquisto di azioni proprie, di cui all’art. 5 del Regolamento (UE) n. 596/2014 (la “**MAR**”), comunicato al mercato in data 28 novembre 2025 ed avviato in data 1 dicembre 2025 per massime n. 10.000.000 azioni ordinarie (il “**Programma**”) a servizio del “*Piano di Incentivazione di Lungo Termine 2021-2023*” (con riferimento alla c.d. “Seconda Quota Differita”), del “*Piano di Incentivazione di Lungo Termine 2022-2024*” (con riferimento alla c.d. “Prima Quota Differita”), del “*Piano di Incentivazione di Lungo Termine 2023-2025*” (con riferimento alla c.d. “Quota Immediata”) e del Terzo Ciclo (2025) del “*Piano di Azionariato diffuso 2023-2025, rivolto alla generalità dei dipendenti*” (congiuntamente, i “**Piani di Incentivazione Azionaria**”), MAIRE S.p.A.
